**FREQUENTLY ASKED QUESTIONS (FAQs)**

Are hotels, B&B, Homestay  
and hospitality services  
allowed to open?



**YES**

All hotels, B&B, Homestays and hospitality services shall be **allowed to open** in the state. However, such **services will remain closed in containment zones**. People from **other states** need to get their **RT-PCR test** from **ICMR authorised lab** with negative COVID-19 report **conducted** not earlier than **72 hours** from the **time of arrival**, or else they need to have a **minimum booking** of **7 days** in a hotel, B&B or homestay. All tourists must register themselves on the web portal (<http://smartcitydehradun.uk.gov.in>)

What about tourists from non high COVID-19 infected cities who carry medical certificates. Will they need to be quarantined?



**NO**

The tourist coming from non-high COVID-19 cities carrying RT-PCR test from **ICMR authorised** lab not earlier than 72 hours from the time of arrival, reflecting **COVID-19 negative** report **don't** need to be **quarantined** and can **roam freely** within the state.

Can tourists from high load/non high load COVID-19 infected cities without a medical certificate visit Uttarakhand? Would they need mandatory quarantine in the hotels they intend to stay?

**YES**

But they must have a booking for **minimum 7 days in a hotel**. S/he has to stay within the premises of the same hotel for 7 days. After this s/he can visit any place within the state.



What about people not carrying a negative RT-PCR test report? Are they allowed in the state?



**YES**

People coming from high load Covid-19 infected cities not carrying a negative RT-PCR test report must undergo a period of 7 days in institutional quarantine and subsequently 7 days in home quarantine.

**Will tourist be allowed to go out of hotel premises after completion of mandatory 7 days hotel confinement ?**

**YES**

After completion of the 7 day period they can travel anywhere.



The clause of  
Mandatory 7 nights  
stay is compulsory  
for even guests from  
within the state?



**NO**

Such restriction of 7 night mandatory stay is not required for guests within the state. No permit/permission shall be required for inter-district movement of persons within the state. However, all such persons shall mandatorily register themselves on the web portal <http://smartcitydehradun.uk.gov.in>, prior to their movement.

**YES**

But they need to get their RT-PCR test from **ICMR authorised** lab with negative COVID-19 report **conducted** not earlier than **72 hours** from the time of arrival. All such tourists shall have to upload the **negative test** report while **registering themselves** on the web portal <http://smartcitydehradun.uk.gov.in>, prior to their movement.
