This is to inform you that the upper limit fixed (as mentioned at para 5.3.10. and 5.3.10.2.) for certain categories of inbound people to Uttarakhand are removed and wherever RT-PCR test is mentioned (Para: 5.3.1, 5.3.10, 8.2.1, 8.3 and 8.4) may be read as "**RT-PCR test by ICMR authorised lab or TrueNAT test**".

As directed in the MHA letter No. 40-3/2020-DM-I(A), dated 22<sup>nd</sup> August, 2020, there shall be no restriction on interstate and intra-state movement of persons and goods. No separate permission/ approval/ e-pass will be required for such movement.

In the above mentioned context, it is again clarified that the inbound person to Uttarakhand shall mandatorily register themselves on <http://smartcitydehradun.uk.gov.in> (smart city portal) as mentioned in the point D, para 5.1 of the letter No. 505/USDMA/792(2020), dated, 4<sup>th</sup> August, 2020. Though the registration is mandatory, no permission/ approval/ e-pass shall be required for such movement. The registration document shall necessarily be verified at the border check post, while the inbound person is making entry in to

the state. The registration is made compulsory to make the contact tracing of the inbound person easy, if, in case, she/ he is found Covid-19 positive latter.

You are requested to take necessary action for its implementation on the ground.
